VII. Financial Report given by WRDR – Bond Debt – Though revenue bonds, the tax dollars will pay. There is bit of a timing issue, interest due on debt issue in 2021. Tax dollars have not been collected yet so some of the funds are fronting that. Bond Interest is \$15,000. Shifted back after the taxes. Unsure of the economic effect on the timing difference. We now have a budget, and we will be incorporating the budget in our regular reports. You will be able to see under certain line items where the budget is. If we will have to move money for one to cover that other. Works with accountability from all sides. Interest is typically 2 times per year. If we do not have the funds by 12/1. We may have to borrow.

- 3) Discussion for Connor and Gallagher to become the Justice Park District's health insurance Catie Crnkovich presented
  - o Full-Service Employee Benefits Program for Insurance
  - Focused on small to mid-size business's
  - o Independently owned private company
  - Entire Team is backing you i.e. practice Leader, Benefits Consultant, Client Services,
     Wellness Coordinator, Nutritionist, COBRA specialist, and numerous Managers.
  - We meet annual through the year to make sure they have the most competitive and valuable benefits in place.
  - Executive Director Bonbrake will be relived of a lot of administrative duties she is currently handling with PDRMA's plan.
  - o Identical plans that PDRMA offers (HMO is only offered with PDRMA plans)
  - Cost is lower than PDRMA
  - Coverage is the exact same, but employees will be offered whether they want and HMO or a PPO.
  - o Notice will need to be given to PDRMA by October 2022.
  - Able to have 2 employees on the HMO and 1 employee can be on PPO and there will be no issues, employee can choose the plan that works for them.
  - Action will be taken in July meeting
  - They will be able to handle our property insurance as well in 2025 when PDRMA's plan is up
