Mary hasn't heard anything.

4. Presentation of the 2020 Audit Report Given by Evans, Marshall & Pease, P.C. Certified Accountant and Consultant

Presented by Chris – Hired 8 months ago – 2018, 2019, and 2020. 2018 and 2019 is done. As far as 2020 it was difficult getting the information needed as the current director was not here. Park District is now caught up. Only issue for 2020 there was not an itemized budget, Summary sheet was found and moved all the items to the general funds. Joe Vallez is no longer here, and it was difficult getting in contact with him and when Chris tried Joe Vallez was sending him things from other parks districts. We did break even with the 2020. Need to levy and what you will be spending. \$159,000 in cash – issue bonds to help with construction.

Bosworth – On the budget you see Pensions – who has a pension here. Is it normal to use the general fund for pensions? Most likely out of general fund – we are only liable for the 2 employees.7.73% is all the district is liable for.

Bosworth – Income dropped in programming assuming that is due to Covid? Yes.
